YOU WILL BE ASKED THE FOLLOWING QUESTIONS BY THE POLICE DISPATCHER

- 1. Your Address and Name
- 2. Direction and Mode of travel of the Suspect or Suspects

East-West-North-South, on what street? Is he on Foot, or in an Automobile?

Give the Color of the Vehicle, the Year, the Make, the Body Style, and the License

3. A Physical Description of the Suspect Sex and Race: White-Black-Oriental

Approximate Age: 15-18, 18-21, 21-24, etc.

Approximate Weight and Height: 140-155, 5'9'45'11'', etc.


Hair and other Identifying Marks: Length, Color, Style, Beard, Mustache, Scars, Tattoos, etc.

- Clothing Description: Type and Color Hat, Coat, Shirt, Sweater, Pants, Shoes, etc.
- Description of Weapon, if Applicable Handgun, Rifle, Shotgun, Knife
 Silver in color or Blue Steel
- Description of Property Taken
 U.S. Currency, Jewelry, Clothing, Household Goods, Appliances, etc.
